Visitors: MaryLou & Glenn Reilly – Mrs. Reilly asked if residents are required to get an inspection for

renting their home, but not as a short-term rental. Mr. Treat clarified that the inspection for short-term rentals is only for homes that are rented for a period of 29 days or less, not long term.

<u>Chris Davies</u> – Mr. Davies asked if when the 2024 proposed budget was created, where the discrepancy of the assistant roadmaster wages came from and where those funds went. Mrs. Oziemblo said she had made a clerical error and there should not have been any funds in that

line and it was corrected in the adopted budget.

Unfinished Business:

a. Fire Tax Funds – Mr. Wittenbrader made a motion to award 50% of the fire tax funds to Greene-Dreher Volunteer Fire Company and to have the secretary notify Promised Land Volunteer Fire Company that the board requests their attendance at the February meeting for them to provide the previously discussed documents and proof of a new bank account for the purpose of the fire tax funds. Mr. Krautter seconded; motion carried.

New Business:

- a. Purchase of Trailer Mr. Wittenbrader explained that the township is in need of purchasing a new trailer to replace the one just sold. Mr. Wittenbrader made a motion to purchase a Eager Beaver 20XP trailer from Marshall Machinery for \$29,665.00 with the condition they provide a new quote with their Costars vendor number included. Mr. Krautter seconded; motion carried.
- b. **Caruso Skyview Lakes Lot Improvement** The board reviewed the plans and determined that the Planning Commission's minutes reflect new deeds must be submitted to the township. Mr. Treat recommends all documents be correct before approving plans in order

to avoid conditions not being fulfilled. Mr. Krautter made a motion to deny the plans until all documents are correct and submitted to the township. Mr. Wittenbrader seconded; motion carried.
